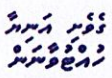

HOTELS/GUESTHOUSES FOR ISOLATION AND QUARANTINE – COVID-19

The Government of Maldives (“GOM”) represented by the Ministry of Tourism (“MOT”) invites eligible hotels/guesthouses to submit their Proposal for the project specified below;

Project – to operate 03(three) Hotels/Guesthouses with minimum 45 rooms in total as Isolation and Quarantine facility in Hulhumale’ to accommodate the positive and direct contact cases of Covid-19 from tourism industry.

Pre-requisites

1. Minimum 45 rooms should be available for Isolation and Quarantine purposes with the 03 hotel/guesthouse combined.
2. The hotel/guesthouse must be located in Hulhumale’
3. The hotels/guesthouses must be available for at least 03 month for the above-mentioned purposes.
4. Below mentioned services should be available for all the tourist/staff isolated/quarantined in the hotels/guesthouses;
 - Accommodation
 - 3 meals per day (International menu)
 - 3 bottles (1.5 litres) of mineral water per person
 - Tea/ Coffee arrangements
 - Internet Services (WiFi) – In room
 - TV Services with at least 10 international channels
 - Laundry Services
 - Housekeeping arrangements (Basic room amenities)
5. Security should be provided.
6. Facilities should be separately allocated for Isolation and Quarantine.
7. Mandatory PCR testing arrangements and transportation of sample to a testing laboratory including payments should be ensured by the hotels/guesthouses.
8. Adequate stock of PPE should be made available.
9. All services rendered by the hotels/guesthouses should comply with all regulations & guidelines published by relevant authorities.





Price

1. The party who fits the criteria and propose the lower price will get the maximum marks.
2. The maximum price that can be proposed is USD70 (Sixty Dollars) with all taxes per room per day for a single person. Any Additional guest to the room can be charged as below;
 - USD30 (Thirty Dollars) including all taxes for an adult.
 - USD15 (Fifteen Dollars) including all taxes for a Child.
3. It is the responsibility of the hotel/guesthouse to collect the payment from the guests.
4. All the services stipulated in point (4) of the prerequisites should be included in the aforementioned price.

Additional Information

- The Government will do the needful in relation to the health monitoring of the tourist/staff isolated or quarantined in the hotels/guesthouses.
- The hotels/guesthouses will be inspected by the Health Protection Agency and Ministry of Tourism prior to awarding the project in order to ensure the suitability of the facility for the aforementioned purpose.

1. Letter of Application- indicating Name, title address and telephone number, email of the Principal who will serve as the Contact for this project and make decisions for the firm on contractual matters.
2. Company Profile - details of the firm, company or partnership profile, expertise, resource capacity and brief background of senior management personnel.
3. Company Registration Copy.
4. GST Registration Certificate Copy.
5. Services – Services the hotels/guesthouses can provide.
6. Price including taxes - Proposed price with details.

The proposal must be written in English.
